## INSTRUCTIONS FOR USE

#### **IMPORTANT**

It is advisable to check the integrity of the mask before use. If you notice the presence of damage and / or stains, order a new mask.

The NR symbol in the marking indicates that the mask is not reusable and must be discarded at the end of the work shift.

The protection offered by an FFP3 or FFP2 filter mask includes that offered by the FFP1 class.

#### **INSTRUCTIONS FOR PLACING THE MASK:**

- 1. Slightly open the mask and, using a finger, shape the nasal bridge to give it the shape of the nose.
- 2. Place the mask against your face and hold it by placing the elastic bands over your ears.
- 3. Using both hands, shape the clip around the nose.
- 4. Make sure that the mask adheres well to the face there should be no spaces between the mask and the face.
- 5. Replace the mask immediately if you have difficulty breathing or if the mask is damaged, or if there are problems with adhesion to the face. Respecting these instructions carefully is essential for the safe use of the respirator.
- 6. Clean your hands with soap and water or an alcohol-based solution before and after using the mask.

#### WARNINGS: [PPE - Personal Protective Equipment]

If it is impossible to obtain an adequate adhesion of the mask to the face profile, do not enter environments with potential risk.

Failure to follow the instructions provided can lead to misuse of the PPE and cause illness and death.

This product does not provide oxygen. It should only be used in adequately ventilated environments, with sufficient oxygen content to maintain life.

Do not use when concentrations of contaminants are immediately hazardous to health or life.

Do not use in an atmosphere where there is a danger of explosion.

Beard hair and respiratory conditions can reduce the efficiency of these filter masks. In addition, there may also be a reduction in the performance of the mask if the mask is damp or wet (the mask must be replaced).

Do not modify or alter the filter mask in any way.

For single use only.

Dispose of the mask after each use.
